WHEREAS, the Village of Greenup, Illinois, previously enacted An Ordinance Authorizing the Operation of All-Terrain Utility Vehicles on the Village of Greenup Streets Under the Jurisdiction of the Village of Greenup, Cumberland County, Illinois (Ordinance No. 415);

WHEREAS, the Village of Greenup, Illinois, wishes to change the registration fee for golf carts as provided in Subsection C of said Ordinance; and

WHEREAS, the Village of Greenup, Illinois, wishes to amend Ordinance No. 415 with respect to the cost of a permit under said Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: The findings made in the prefatory portion of this Ordinance are hereby adopted.

Section 2: That the cost for a permit under Subsection C(1) is changed to reflect an amount of FORTY-FIVE DOLLARS (\$45.00).

Section 3: That in all other respects, said Ordinance remains in full force and effect.
