AN ORDINANCE AMENDING ORDINANCE 417  
AN ORDINANCE AUTHORIZING THE OPERATION OF GOLF CARTS ON THE  
VILLAGE OF GREENUP STREETS

WHEREAS, the Village of Greenup, Illinois, previously enacted An Ordinance Authorizing the Operation of Golf Carts on the Village of Greenup Streets (Ordinance No. 417); and

WHEREAS, the Village of Greenup, Illinois, wishes to change the permit fee for golf carts as provided in Subsection C of said Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS, AS FOLLOWS:**

Section 1: The findings made in the prefatory portion of this Ordinance are hereby adopted.

Section 2: That the cost for a permit under Subsection C(1) is changed to reflect an amount of FORTY-FIVE DOLLARS (\$45.00).

Section 3: That in all other respects, said Ordinance remains in full force and effect.
