IN NO EVENT SHALL THE VILLAGE BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER ARISING IN TORT, CONTRACT OR ANY OTHER LEGAL THEORY, IN CONNECTION WITH OR ARISING OUT OF OPERATOR'S USE OF A GOLF CART, ALL-TERRAIN UTILITY VEHICLE, OR MOTORIZED BICYCLE ON VILLAGE STREETS.

I understand that the Village has an ordinance governing the use of Golf Carts, All-Terrain Utility Vehicles and Motorized Bicycles on Village Streets and herby agree to conform with ALL requirements of the Village ordinance at all times. I have had the opportunity to read said ordinance and my signature below acknowledges that I will comply with this ordinance and all applicable traffic laws of the State of Illinois at all times when operating this Golf Cart, All-Terrain Utility Vehicle or Motorized Bicycle on Village streets.
