ORDINANCE NO. 735

AN ORDINANCE LEVYING THE TAXES FOR THE CORPORATE PURPOSES OF
THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS FOR THE
FISCAL YEAR ENDING ON THE 30TH DAY OF APRIL 2025

WHEREAS, the Board of Trustees of the Village of Greenup, Cumberland County, State of Illinois, did, on the 2nd day of December 2024, passed Ordinance No. 734, An Amendment to the Annual Appropriation Ordinance for the Village of Greenup, Illinois for said Village of Greenup for the fiscal year beginning May 01, 2024 and ending on April 30, 2025, by which said Ordinance there is appropriated the sum of \$9,778,250.00 for the various corporate purposed therein specified, which Appropriation Ordinance was duly and legally presented, read passed and approved by the Village President and the Board of Trustees, and which said Appropriation Ordinance is now on file in the office of the Village Clerk, as provided by law, and that said Ordinance is now in full force and effect.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS:

Section 1: That there be and is hereby levied upon the taxable property within the said Village of Greenup, Cumberland County, Illinois, subject to taxation for the corporate purposes of said Village for the year beginning May 01, 2024 and ending April 30, 2025, the sum of \$301,610.12 for the following specific purposes mentioned in said Appropriation Bill and in the respective sums as follows:

Section 2: That the Village Clerk shall make and file with the County Clerk of the County of Cumberland, a duly certified copy of this Ordinance and that the amount levied by Section 1 of this Ordinance is required by said Village of Greenup, County of Cumberland and State of Illinois, as aforesaid and extended upon the appropriate tax books for the fiscal year of said Village of Greenup, County of Cumberland, and State of Illinois, beginning May 01, 2024 and ending April 30, 2025.

Section 3: If any section, subdivision, sentence, or clause of the Ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 4: This Ordinance shall be in full force and effect ten (10) days from and after passage and approval and may be viewed in the Village Clerk's office as proved by law.

Section 5: If there is an error in printing, the publishing requirement of this act shall be accomplished by reprinting that portion of the Ordinance which was in error as above enumerated within 30 days after passage is validated.




