Electric Systems, Alternate Revenue Source Bonds of the Village of Greenup; and

WHEREAS, the Village of Greenup, IL has the intent to maintain these funds for said  
bond expenses; and

WHEREAS, the amount of \$84,890.00 is not necessary for the payment of bond  
expenses.

NOW THEREFORE, BE IT HEREBY ORDAINED BY THE VILLAGE BOARD  
OF TRUSTEES OF THE VILLAGE OF GREENUP, CUMBERLAND COUNTY,  
ILLINOIS THAT:

The amount of taxes to be extended for 2024 payable in 2025 shall be reduced by the  
abatement of \$84,870.00.
