**ORDINANCE APPOINTING JASON REISNER TO THE  
ILLINOIS MUNICIPAL ELECTRIC AGENCY BOARD OF DIRECTORS**

WHEREAS, the Village of Greenup is a Member of the Illinois Municipal Electric Agency; and

WHEREAS, each Member of the Agency is entitled to a representative on the Board of Directors of the Illinois Municipal Electric Agency, which representative is to be appointed by the President and confirmed by the Board of Trustees; and

WHEREAS, the President has appointed Jason Reisner, who is the Electric Utility Lead of Greenup Utility Department to be the Village's representative on the Illinois Municipal Electric Agency Board of Directors.

BE IT HEREBY ORDAINED by the Board of Trustees of the Village of Greenup, Cumberland County, Illinois that the appointment by the President of the Village of Greenup, to be the Village's representative on the Illinois Municipal Electric Agency Board of Directors is hereby confirmed, said appointment to be effective August 4, 2025 for the remainder of the current term of said representative and thereafter until his/her successor is duly appointed, confirmed and seated.

BE IT FURTHER ORDAINED that said representative shall have full power and authority to vote as the representative of the Village of Greenup in conjunction with all Illinois Municipal Electric Agency matters.


