NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF GREENUP, ILLINOIS AS FOLLOWS:

SECTION ONE: The recitals set forth hereinabove are hereby incorporated as findings as if said recitals were fully set forth within this Section One.

SECTION TWO: The Mayor, with the advice and consent of the Village Board, appoint Hannah Scales as Village Treasurer effective October 6, 2025.

SECTION THREE: Repeal of Conflicting Provisions. All ordinances, resolutions, and policies or parts thereof, in conflict with the provisions of this Resolution are, to the extent of the conflict, expressly repealed on the effective date of this Resolution.

SECTION FOUR: Severability. If any provision of this Resolution or application thereof to any person or circumstances is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provision or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

SECTION FIVE: The Village Clerk is hereby directed to publish this Resolution.

SECTION SIX: This Resolution shall be in full force and effect from and after its adoption as provided by law.
