# A RESOLUTION APPROVING AN UPDATED UTILITY POLE LICENSE AGREEMENT WITH MEDIACOM COMMUNICATIONS CORPORATION. FOR THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS

**WHEREAS**, the Village of Greenup, Illinois ("Village") is a duly organized and existing municipal entity organized and operating under the constitution and laws of the State of Illinois; and

**WHEREAS**, the Village of Greenup has been operating under an Agreement for the Joint Use of Poles with Tri-Star Cablevision, Inc. since 1981; and

**WHEREAS**, pursuant to said agreement, the Village was receiving an annual payment of \$3.00 per pole that was being utilized by Tri-Star Cablevision; and

WHEREAS, that in 2001, Tri-Start Cablevision was acquired by Mediacom Communications Corporation who began making annual payments to the Village pursuant to the 1981 agreement; and

**WHEREAS**, the Village wished to renegotiate the terms of the agreement so that it aligned with modern needs and modern rates; and

WHEREAS, in furtherance of said efforts, the Village and Mediacom Communications Corporation have negotiated a new proposed agreement which would raise the annual gross rent payable to the Village to \$7.50 per pole, said agreement attached hereto in its entirety as "Exhibit A"; and

WHEREAS, said rate of \$7.50 is based on the Handy-Whitman Index ("HWI") and is comparable to rates within the region; and

## NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF GREENUP, ILLINOIS AS FOLLOWS:

**SECTION ONE:** The recitals set forth hereinabove are hereby incorporated as findings as if said recitals were fully set forth within this Section One.

**SECTION TWO:** The Mayor, with the advice and consent of the Village Board, approves the proposed Utility Pole License Agreement attached hereto as "Exhibit A," subject to final attorney-review.

**SECTION THREE:** Repeal of Conflicting Provisions. All ordinances, resolutions, and policies or parts thereof, in conflict with the provisions of this Resolution are, to the extent of the conflict, expressly repealed on the effective date of this Resolution.

**SECTION FOUR:** Severability. If any provision of this Resolution or application thereof to any person or circumstances is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provision or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

**SECTION FIVE:** The Village Clerk is hereby directed to publish this Resolution.

**SECTION SIX:** This Resolution shall be in full force and effect from and after its adoption as provided by law.
