## A RESOLUTION APPOINTING DANIEL FINLEY, JODY SHOOT, AND MICHELLE FRYMAN AS DEPUTY CLERKS FOR THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS

WHEREAS, the Village of Greenup, Illinois ("Village") is a duly organized and existing municipal entity organized and operating under the constitution and laws of the State of Illinois; and

**WHEREAS**, current Village Clerk, Jill Kimble, is anticipated to retire in early 2026; and

**WHEREAS**, Michelle Fryman has been hired to succeed Village Clerk Jill Kimble upon Jill's retirement; and

**WHEREAS**, the Village Clerk has been working with and training Michelle Fryman, Daniel Finley, and Jody Shoot in fulfilling the day to day administrative operations at Greenup Village Hall; and

**WHEREAS**, the Illinois Municipal Code (65 ILCS 5/3.1-30-10) permits the municipal clerk, when authorized by the corporate authorities, to appoint the number of deputy clerks necessary to discharge the functions and duties of the office of municipal clerk; and

WHEREAS, in furtherance of said training efforts and to ensure the seamless transition of the Village Clerk position, current Village Clerk, Jill Kimble, would like to appoint Michelle Fryman, Daniel Finley, and Jody Shoot as Deputy Clerks so that they may complete necessary training and receive necessary certifications for the Open Meetings Act, Freedom of Information Act, Illinois Municipal Retirement Fund, and other items relevant to local government operations; and

### NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF GREENUP, ILLINOIS AS FOLLOWS:

**SECTION ONE:** The recitals set forth hereinabove are hereby incorporated as findings as if said recitals were fully set forth within this Section One.

**SECTION TWO:** The Mayor, with the advice and consent of the Village Board, appoint Michelle Fryman, Daniel Finley, and Jody Shoot as Deputy Clerks effective November 3, 2025.

**SECTION THREE:** Repeal of Conflicting Provisions. All ordinances, resolutions, and policies or parts thereof, in conflict with the provisions of this Resolution are, to the extent of the conflict, expressly repealed on the effective date of this Resolution.

**SECTION FOUR:** Severability. If any provision of this Resolution or application thereof to any person or circumstances is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provision or applications of this Resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

**SECTION FIVE:** The Village Clerk is hereby directed to publish this Resolution.

**SECTION SIX:** This Resolution shall be in full force and effect from and after its adoption as provided by law.
