

ORDINANCE 762
APPOINTING JOHN KNUEPPEL TO THE
ILLINOIS MUNICIPAL ELECTRIC AGENCY BOARD OF DIRECTORS

WHEREAS, the Village of Greenup, Illinois is a Member of the Illinois Municipal Electric Agency; and

WHEREAS, each Member of the Agency is entitled to a representative on the Board of Directors of the Illinois Municipal Electric Agency, which representative is to be appointed by the Mayor and confirmed by the Board of Trustees; and

WHEREAS, the Mayor has appointed John Knueppel, who is a Utility Department Laborer to be the Village's representative on the Illinois Municipal Electric Agency Board of Directors.

BE IT HEREBY ORDAINED by the Board of Trustees of the Village of Greenup, Cumberland County, Illinois that the appointment by the Mayor of John Knueppel, to be the Village's representative on the Illinois Municipal Electric Agency Board of Directors is hereby confirmed, said appointment to be effective May 4th, 2026 for the remainder of the current term of said representative and thereafter until his/her successor is duly appointed, confirmed and seated.

BE IT FURTHER ORDAINED that said representative shall have full power and authority to vote as the representative of the Village of Greenup in conjunction with all Illinois Municipal Electric Agency matters.


